## GRIEVANCE / NEGOTIATIONS UPDATE

On Sunday Sept 21<sup>st</sup> the district wide all members meeting took place. Members from all seven of Ottawa's OSSTF Bargaining Units came out to hear important information on upcoming negotiations and to take part in 2 strike votes, a provincial vote and a local vote. There was a large turnout of members in attendance. A strong feeling of solidarity was in the room as President Paul Elliot, Vice President Cindy Dubue, Provincial Office Staff and our Local Executives explained what could be expected with upcoming negotiations. Results of the local strike vote for our unit were 96% in favour. We are sending a solid message.

The first meetings at the Support Staff central table (Provincial bargaining between OSSTF, representatives of the 4 public school boards and the Ministry of Education) took place Oct 6<sup>th</sup> and 15<sup>th</sup>. As with any round of collective bargaining the integrity of the process require that details not be made public until an agreement is reached. In fact, the ground rules for this round impose a media blackout during negotiations. Again, any information that can be shared will be found in the members' only section and must be kept confidential to OSSTF members.

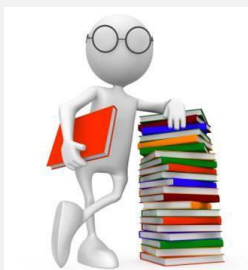

### LEARN YOUR COLLECTIVE AGREEMENT

#### 24.04 Postings for Positions of Responsibility

Effective January 1, 2014, the Board will no longer be maintaining transfer lists.

- (a) Position of Responsibility vacancies shall be posted and filled in the following order:
- (i) requests for a lateral transfer, in order of seniority (Note: Employees who elect a lateral transfer will not be eligible for another lateral transfer for six (6) months from the earlier of their start date in the position or the first posting in August);
  - (ii) offered to members on the recall list, in order of seniority, subject to Article 25 (Layoff and Recall); then
  - (iii) applications from members on the Positions of Responsibility eligibility list, in order of seniority.
- (b) The employee identified in accordance with Article 24.04(a), by their request/application, will be deemed to have accepted the position.
- (c) In the event that there are no applicants from the Positions of Responsibility eligibility list, the Employer will draw from the new Positions of Responsibility eligibility list as of May 1<sup>st</sup>. In the event that the Positions of Responsibility eligibility list(s) are exhausted, the position will be filled as an acting or term assignment until the next Positions of Responsibility eligibility list is established.

Brief definition: The Human Resources Department no longer has transfer lists. If you are interested in transferring you must be checking postings on a regular basis and apply using the Apply To Education website. Be sure when you apply to any postings that you only apply to locations which you are willing to move to. You are encouraged to keep the email receipt you receive when you apply for a position. If you apply for a position and are the successful candidate, you have been deemed to have accepted that position and must move on the specified date. You cannot move again (except for a promotion) for 6 months or the beginning of the next school year, starting with the postings that begin at the end of August.
